Access to the Jenoptik premises



We are obliged to perform screening of all visitors and contractual partners of Jenoptik against valid sanction lists while using information such as name, nationality and institution of origin. Please have a valid ID with you.

Rules for visitors

Access and movement on the company premises



Please wear your visitor badge clearly visible during the entire stay on the company premises.



Visitors are always accompanied by Jenoptik employees within the company premises. Access to security areas is only permitted to visitors after a security check.



Please only use the marked paths and corridors.

Some of the work premises are visibly equipped with barriers or are marked with warning signs such as "NUR FÜR AUTORISIERTES PERSONAL" (ger.: Only for authorized personnel). In case you stay at or near such premises, please follow the instructions of the trained staff who work there.

Driving and parking, speed limit





The factory site is only accessible to employees, guests, and delivery traffic. Employees can use the parking facilities with access from the Knappsdorfer Strasse. The delivery access and guest parking area are adjacent to the Knappsdorfer Strasse.

Vehicles that endanger safety and/or restrict the movement of others will be removed against payment. The usual traffic regulations and a speed limit of 10 km/h apply on the entire premises, including the parking lots.

Taking and bringing items with you



You are not allowed to carry any objects away including, but not limited to, documentation, without an explicit consent of the person you are visiting or of another authorized member of the staff.

It is forbidden to use any portable memory media like FD, CD, DVD, USB devices, or HDD on all computers connected to Jenoptik network.

Smoking and drug ban




Smoking is permitted only at designated smoking areas. The use of fire and open light requires the approval of the property management or the fire safety officer.

You may not enter the building under the influence of alcohol or drugs. Hosts or security personnel are authorized to ask you to undergo appropriate tests.

Prohibition of photography



Filming and photography (including with cell phones) is prohibited on the entire company premises (except with the permission of authorized Jenoptik employees).





Safety & security



Our buildings and grounds are monitored 24/7 by security guards and video cameras.

Surroundings, goods and materials





It is always necessary to follow instructions of the company's employees with regard to possible risks in the workplace, such as: cranes operation, forklifts, electrical and other equipment, use of chemicals, gases or pressure vessels.

In the areas intended for the transportation of materials, goods and merchandise, please pay attention to forklift and trolley traffic as well as suspended loads under the crane systems.





Please be aware of general hazards such as tripping, bumping, falling and crushing hazards, vehicle traffic and production-related technological hazards such as laser radiation, electromagnetic fields, heat radiation, etc. throughout the entire company premises.

Do not touch anything



Please do not touch any workpieces, materials, machines or devices as you could endanger yourself, the production process or the product.

Protective equipment

Please only enter areas where personal protective equipment is required with this protective equipment. As a visitor, you can borrow the appropriate equipment from your host.









Environmental protection



Be aware of your impact on the environment and act accordingly.

When working, always adhere to applicable legislation and regulations of JENOPTIK Optical Systems GmbH.

When working with dangerous substances, please ensure their qualified use, proper storage and safe disposal, so that neither the environment nor safety are threatened



Avoid waste generation, and if it occurs, dispose it according to internal company requirements on waste separation and in accordance with law. If during your activity hazardous waste is generated, ensure its disposal at your own expense.

When using energy sources, please try to use them economically.

First aid



In the event of an injury, inform the person you are visiting or the reception desk. A first aid board with a first aid kit and important telephone numbers, such as those of first responders, is available at reception. Additional first aid boards are located in all areas and are marked on the escape and rescue route plans. Defibrillators are also located at the reception and in the area in front of the clean room.

Behavior in an emergency case



In case of emergency, follow the existing directives created for the situation and instructions from the person you are visiting, the head of the department you work in or call the reception.



- Leave the building immediately using the shortest escape route.
- Pay attention to the escape route signs.
- Follow the Jenoptik employees to the assembly point.
- Always follow the instructions of Jenoptik security personnel.
